White milk products are fortified to California State Standards (BF/MSNF): Whole Milk $3.5 \% / 8.7 \%$; Reduced fat $2 \% / 10 \%$; Lowfat $1 \% / 11 \%$; Nonfat (skim) $0.10 \% / 9 \%$. In lieu of the final Class IV skim price which is not available before the 24th of the month, the advanced Class IV skim price is used. Pounds per gallon factors are based on the formula: (100/(100+(BF\% X 0.04811)-(MSNF\% X 0.38556)) X 8.3341.
