Previously announced in Announcement of Class I Price and Advanced Pricing Factors. Class I prices are announced at the Los Angeles County, CA location differential of \$2.10 per hundredweight.

The Class prices announced are per hundredweight at 3.5% butterfat.

The 20-cent per hundredweight processor assessment is an obligation under the Fluid Milk Promotion Order (7CFR§1160.101 <u>et seq.</u>) imposed on any person who processes and markets commercially more than 3 million pounds of packaged fluid milk products on a monthly basis. Deliveries to consumer residences are excluded. Effective February 29, 2016, processors of certified "organic" and "100 percent organic" fluid milk products may apply for an organic assessment exemption for those products.
